### YEAR IN REVIEW

### **OPERATIONS**

### New Applications received during fiscal year:

- 40 Land Use Permits, 6 Water Licences.
- 50% of the permit applications were for mineral exploration.
- Of the 46 total applications, 6 were subsequently withdrawn.
- 16 of the remaining 40 applications were deemed incomplete when received but subsequently completed by proponents.
- Average days to decision on majority of these Land Use Permits = 38
- Security assessed on permits and licences excluding Snap Lake \$662,000.
   Security on Snap Lake Diamond mine \$30 million.

### Land Use Permit and Water Licence matters dealt with by MVLWB during fiscal year:

- Amendments to existing permits/licences 28
- Assignments of existing permits/licences 10
- Closures of completed permits 49
- Decisions on permit/licence applications 58
- Extensions of existing permits 16
- Renewals of existing licences **3**
- Reports required as a condition of a licence 36
- Storage Authorizations for equipment 1
- Applications referred to Environmental Assessment 5

- On-site tours by Board and staff of Snare Hydro Project.




### INTO THE FUTURE

The MVLWB met in Inuvik in April of 2005 to begin charting a new course for the organization. Board members sent a strong message that they want the organization to "get down to business". This means concentrating on regulating "the use of land and water, and the deposit of waste so as to provide for the conservation, development and utilization of land and water resources ..."

The first order of business that the Board approved was a full review of all existing By-laws, Rules, Policies, Procedures and Guidelines for not only the Mackenzie Valley Land and Water Board, but for the regional panels of the Board, the Gwich in Land and Water Board and the Sahtu Land and Water Board. This review will determine what gaps exist in providing the information that all stakeholders in the process need. It will also look at how the Board can promote greater regulatory consistency throughout the Mackenzie Valley by standardizing processes where possible.

In the coming year, the Board will also be examining other tools it has to regulate land and water use effectively and will be initiating a number of projects to improve those tools. At the same time, the Board recognizes the unique nature of the settled claims areas and will assist regional panels in developing and maintaining processes that support their specific claims agreements.
